**Mayor White:** We did discuss a little bit about benefits and stuff for the chief, as you know Chief Janousek does both the city and county as Fire Chief and he does work for the city and prior to that I talked to people, there is a lot of cities that do the same, normally it is the Superintendent of Public Works, then they are the Chief but here it is Derik is a crew member and the Fire Chief. We talked about some roles and responsibilities. Are there any questions that you have about the way the rural and city are interacting?

**Mayor White:** We jumped out early and did some resolutions back in 2020, and I think now with the reopening guidelines that the governor issued here a while back, and he has a reopening plan that these resolutions are no longer valid or needed so therefore I am recommending that we motion a resolution tonight to repeal Resolutions 20-01, 20-02, 20-03, 20-04.

**Mayor White:**

A RESOLUTION OF THE CITY OF GLENN'S FERRY, ELMORE COUNTY, IDAHO, DECLARING RESOLUTION No. 20-01, RESOLUTION No. 20-02, RESOLUTION No. 20-03, AND RESOLUTION No. 20-04 REPEALED AND VOID.

WHEREAS, the health, the wellbeing and safety of the citizens of the City of Glenns Ferry, Idaho is the highest priority of the Mayor and City Council; and

WHEREAS, the Governor of the State of Idaho has issued reopen Idaho guidelines and protocols, and the City of Glenns Ferry is a political subdivision of the State of Idaho, the Resolutions are no longer needed; and

WHEREAS the City Council and Mayor believe that the citizens of the City of Glenns Ferry are more than able to protect themselves, their businesses, and families.

**Galloska:** Second

**McFarland:** Roll call vote, Councilwoman Case-absolutely yes, Councilman Thompson-agreed absolutely yes, Councilman Galloska-with excitement yes.

**Mayor White:** All in favor, all-eyes. Motion carries

**Item 15. DISCUSSION/MOTION: [ACTION ITEM] DEPARTMENT/COMMITTEE MEMBER REPORT:**

A. **Sheriff Office** – Sheriff Hollinshead/Lieutenant Burnett: absent

B. **Fire Chief** – Derik Janousek:

Janousek: We are busy training.

C. **City Engineer** – Keller Associates, Inc – Donn Carnahan, PE:

**Mayor White:** I sent to all city council, Johnny, the proposal of the sewer lagoons, you have it in your packet so you can study it and we will have it on the next agenda.

D. **Public Works** – Johnny Hernandez:

**Hernandez:** Slide Show: New bathroom location in our shop, our sewer line collapsed under the building and we were able to re-route.

There is a valve that controls the other half of the plant that went out, we were troubleshooting but called in Jeff Cook to get a second opinion. These valves are from Canada and those valves are being expedited as we speak, should be here Thursday. Our water plant is at 50% and it still makes enough water for us. That valve is about \$1400 and then to expedite \$600 but if the other half fails then we have no water.

Derik is fabricating a grate for the drain over by the Dollar Store across the street there's a tunnel that goes under and dumps all the water to the Fairgrounds which is okay because it dumps that water into the grass, but there was a hole in the design because the covert is below grate, so we had to excavate 3 feet and put gravel in and add water so that the pressure could push it up and out.

**Mayor White:** Is that going to help behind JTS?

**Hernandez:** Yes, it's going to help. I got permission from the Fairgrounds. I told them this wasn't working, and we are going to make some adjustments at minimal work and expense.

**Thompson:** The state put it in then?

**Hernandez:** Yes.

Derik working on the valve. That's when we called Jeff Cook in for a second opinion and we were correct. There's our IRWA apprentice program that me and Scott have been doing. It's our Zoom class, that's why I had purchased the TV. We're there four (4) times a month for three (3) hours. A lot of trainings and information that other cities have encountered.

Used the street sweeper to clean out debris over by the Fairgrounds. It goes down and across the street. We have had City Hall flood before. There wasn't a rain gutter there, all that water was dumping off from roof and into the back area which caused more water to flood. Had a company come out and put in a rain gutter so the water will shoot out to the street to help not flood City Hall. It was \$500. The rain gutter behind us here dumped into the backside, had then patch the hole and redirect it so the rain gutter would shoot out into the street. About 50% of the water on the fire department will dump out to the front into the street. It's going to help, but not going to solve the problem.

Here, we did the excavation for the Fairgrounds and that's where the water is supposed to come out. We shot water into the covert to test it out. We'll be able to clean it out and service it. We'll be able to pick it up, it's very sturdy. There you can see the gravel we put in.

There's the water leak we worked on yesterday. I have a sample here on the table of what's going on with our infrastructure. Monty visited the site. Derik is grinding on the pipe; you have to be careful because the pipe is thin.

**Mayor White:** Here awhile back we spent a lot of money on a trailer so that the guys could have all their tools. I went out and inspected it they had all these tools in there and it was very clean, they don't have to take twenty (20) trips to the shop. I just wanted the council to know that we spent the citizen's money wisely. I pulled up onsite and I was very impressed, everyone had their hard hats on, reflective vest. They looked like a professional crew with their safety stuff. All the stuff we buy them, we're not just buying them just to spend money. Johnny has a method to his madness and so does Derik. This stuff is working and getting a lot done.

**Hernandez:** We're just grinding the pipe down, there's a lot of rust. The way it works if it has a pin hole or a crack, there's a band we put around it, but if the pipe is not cleaned off it won't seal. Our pipes are very thin.

That's a perfect example with the dirt ball with the root. That's a piece of the pipe right there. I have it here on my desk if you want to see it. That is pipe in that root ball, and it is in a lot of areas in our town. I'll be honest with you guys, we're going to have a disaster soon, where people are going to be left without water, maybe for days. It is coming. Kansas is bad, Owyhee and Harrison and there's a possibility of something fails people will not have water for days.

**Case:** Do you have a plan, a solution?

**Mayor White:** We're putting in for grants right and left now, we don't have a lot of money left.

**Thompson:** Do we have any reserve?

**Hernandez:** We have money to buy some pipe, but the problem is to do the work, it's not that easy. We can have the pipe, but if the pipe fails, by the time we dig it up. Say it's in the middle of winter, we can't be out there we'll freeze to death. There's a difference from doing a street or a pipe fail. We need to come up with a plan and when I say we I mean all of us because I don't control it. I'm not the CEO here, if I were the CEO, I would have a plan. Here it's grants money, so we really need to have some plans designed soon and get something shovel ready.

**Case:** Is that the engineer that does the plans?

**Hernandez:** We really need to get the ball rolling by next year and get some infrastructure start being replaced.

**Mayor White:** We're trying to get some shovel ready plans in place so in case we're ready and we score a grant or infrastructure money comes from the federal government....

**Case:** And if we don't get a grant?

**Mayor White:** We do not have the money to replace all of this, no.

**Hernandez:** That's the scary part, what you just asked, is the scary part.

**Thompson:** The thing is though, we do need to realize that maybe at one point we will need to replace a lot of pipe and plan for that, even if we have to pay for it out of our own pockets.

**Mayor White:** Between the water plant and the infrastructure underground that we need, you've seen the plans and how much it's costing us, like that 8" water line est. at \$140,000.

**Hernandez:** Which one the loop?

**Mayor White:** Up here for the school....

**Janousek:** \$175,000 to go a block.

**Mayor White:** We are going to have to come up with some money.

**Galloska:** We need to get our priorities set, back that up with a plan and then we start getting the grants. If we're working on the grants before we have all this other stuff in place, I think it won't work out.

**Hernandez:** We should invest in having plans designed and have them ready so if the opportunity does come up, we have plans in hand, we are ready to go.

**Case:** What do you need from us to get the plans rolling?

**Mayor White:** Nothing really, it is up to me and Johnny and the engineer to get these shovel ready plans and then it is up you guys, bringing it before you guys for our funding proposals.

**Case:** Is Keller looking for grants?

**Mayor White:** Yes, and Christy is on it too. We have to have a plan before we can do anything. The people on the grants, the first thing they are going to say is, "Where is your plan?" "How much is it going to cost?" We are trying to get shovel ready projects on the shelf, then all we have to do when a grant comes up is update the numbers. It takes time and it takes money. It cost money for Keller to design it and supervise that project and do the right bidding, so we don't get into trouble with the state.

**Hernandez:** Another thing council needs to think about is inflation, are we keeping up or is that gap becoming too far out of reach.

**Galloska:** What are the barriers that we are causing, or the council as a whole is causing in the years past and how do we get out of the way and start moving towards that direction, frankly I am all for getting on top of this infrastructure stuff, it is a problem.

**Case:** I have to see numbers.

**Hernandez:** You cannot get numbers until you have a plan.
